- 6. Club operation and routine maintenance expenses are not eligible for a grant: Capital Expenditures will be considered. The grant may be used for initial start-up costs and associated expenses for equipment, real estate, or improvements to real estate.
- 7. The club must be in good standing with the District, State and Lions Club International
